## I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

## II. Dosing Limits

### A. Quantity Limit (max daily dose) [NDC Unit]:

- Bavencio 200 mg/10mL single-dose vial: 4 vials per 14 days

### B. Max Units (per dose and over time) [HCPCS Unit]:

- 80 billable units (800 mg) every 14 days (all indications)

## III. Initial Approval Criteria <sup>1</sup>

Coverage is provided in the following conditions:

- Patient is at least 18 years of age, unless otherwise indicated; **AND**

### Universal Criteria

- Patient has not received previous therapy with a programmed death (PD-1/PD-L1)-directed therapy (e.g., nivolumab, pembrolizumab, dostarlimab, atezolizumab, durvalumab, cemiplimab, nivolumab/relatlimab, retifanlimab, tislelizumab, toripalimab, etc.), unless otherwise specified <sup>Δ</sup>; **AND**

### Merkel Cell Carcinoma (MCC) † ‡ Φ <sup>1,2,4,5,1e,2e</sup>

- Patient is at least 12 years of age; **AND**
- Used as single-agent therapy; **AND**
  - Patient has primary locally advanced disease ‡; **AND**
    - Both curative surgery and curative radiation therapy are not feasible; **OR**

- Patient has distant metastatic disease

### **Urothelial Carcinoma (Bladder Cancer) † ‡ 1,4,6,8,16**

- Used as single-agent therapy; **AND**
  - Patient has one of the following diagnoses:
    - Locally advanced or metastatic urothelial carcinoma †
    - Muscle invasive bladder cancer with local recurrence or persistent disease in a preserved bladder treated with curative intent ‡
    - Metastatic or local bladder cancer recurrence post cystectomy treated with curative intent ‡
    - Metastatic upper genitourinary (GU) tract tumors ‡
    - Metastatic urothelial carcinoma of the prostate ‡
    - Recurrent or metastatic primary carcinoma of the urethra (*excluding recurrence of stage T3-4 disease or palpable inguinal lymph nodes*) ‡; **AND**
      - Used for disease that progressed during or following platinum-containing chemotherapy\*; **OR**
  - Used as first-line maintenance treatment; **AND**
    - Patient has locally advanced or metastatic urothelial carcinoma (inclusive of bladder, upper GU tract, urethra, and/or prostate cancer); **AND**
    - Patient has not progressed with first-line platinum-containing chemotherapy

\* *Note:* 6,17,20

- *If patient was progression-free for > 12 months after platinum therapy, consider re-treatment with platinum-based therapy if the patient is still platinum eligible (see below for cisplatin- or platinum-ineligible comorbidities).*
  - *Cisplatin-ineligible comorbidities may include the following: CrCl < 60 mL/min, ECOG PS ≥ 2 or KPS < 70% hearing loss of ≥ 25 decibels (dB) at two contiguous frequencies, or grade ≥ 2 peripheral neuropathy, or NYHA Heart Failure class ≥ 3. Carboplatin may be substituted for cisplatin particularly in those patients with a CrCl < 60 mL/min or an ECOG PS of 2.*
  - *Platinum-ineligible comorbidities may include the following: CrCl < 30 mL/min, ECOG PS ≥ 3, grade ≥ 2 peripheral neuropathy, or NYHA Heart Failure class > 3, etc.*

### **Renal Cell Carcinoma (RCC) † ‡ 1,4,9,14**

- Used in combination with axitinib; **AND**
- Used as first-line therapy; **AND**
- Used for the treatment of advanced, relapsed, or stage IV disease and clear cell histology

Preferred therapies and recommendations are determined by review of clinical evidence. NCCN category of recommendation is taken into account as a component of this review. Regimens deemed equally efficacious (i.e., those having the same NCCN categorization) are considered to be therapeutically equivalent.

## IV. Renewal Criteria <sup>Δ 1</sup>

Coverage may be renewed based upon the following criteria:

- Patient continues to meet the universal and other indication-specific relevant criteria identified in section III; **AND**
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: severe or life-threatening infusion-related reactions, severe immune-mediated adverse reactions (e.g., pneumonitis, hepatotoxicity/hepatitis, colitis, endocrinopathies, nephritis with renal dysfunction, dermatitis/dermatologic adverse reactions, etc.), major adverse cardiovascular events (MACE) when used in combination with axitinib, complications of allogeneic hematopoietic stem cell transplantation (HSCT), etc.

<sup>Δ</sup> Notes:

- Patients whose tumors, upon re-biopsy, demonstrate a change in actionable mutation (e.g., MSS initial biopsy; MSI-H subsequent biopsy) may be eligible to re-initiate PD-directed therapy and will be evaluated on a case-by-case basis.

Patient-specific variables should be taken into account.</i></p>
