## I. Length of Authorization

Coverage will be provided for 6 months and may be renewed.

# II. Dosing Limits

- A. Quantity Limit (max daily dose) [NDC Unit]:
  - 4 mg single-dose vial for injection: 2 vials every 21 days
- B. Max Units (per dose and over time) [HCPCS Unit]:
  - 80 billable units every 21 days

## III. Initial Approval Criteria <sup>1</sup>

Coverage is provided in the following conditions:

• Patient is at least 18 years of age; AND

#### Universal Criteria 1

Used as a single agent; AND

#### Small Cell Lung Cancer † ‡ Φ 1-4

- Used for metastatic disease after disease progression on or after platinum-based chemotherapy
  (i.e., cisplatin, carboplatin) †; OR
- Used as subsequent therapy for relapsed or primary progressive disease ‡

## IV. Renewal Criteria <sup>1</sup>

Coverage may be renewed based on the following criteria:

 Patient continues to meet the universal and other indication-specific relevant criteria such as concomitant therapy requirements (not including prerequisite therapy), performance status, etc. identified in section III; AND



- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; AND
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: myelosuppression (e.g., neutropenia, thrombocytopenia, anemia, etc.), hepatotoxicity, extravasation resulting in tissue necrosis, rhabdomyolysis, etc.

Small Cell Lung	Administer 3.2 mg/m² by intravenous infusion every 21 days until disease progression or	
Cancer	unacceptable toxicity.
