

DHS Incentive Measure 2024 Quick Reference Guide



All children who enter DHS custody are **required** to receive an age-appropriate physical health assessment, dental health assessment and mental health assessment within a certain time period.

| Age of patient at notification | Required Health Assessments | | |
|--------------------------------|-----------------------------|--------|--------|
| | Physical | Dental | Mental |
| < 1 year old | Yes | No | No |
| 1-2 years old | Yes | Yes | No |
| 3-17 years old | Yes | Yes | Yes |

Physical Health Assessments

A qualifying physical health assessment for DHS includes either an office visit or a wellness (well-child) visit that occurs either:

1. 30 days **BEFORE** EOCCO was notified of the patient's case by DHS
2. Within 60 days **AFTER** EOCCO was notified of the patient's case by DHS

EOCCO will send your clinic a notification file each time one of your assigned EOCCO patients enters DHS custody. This notification file will include the patient's DHS notification date, which is the date used to determine the 30-day look-back and 60-day appointment scheduling time frame. The notification file will also include:

- Patient demographic information [EOCCO Member ID, First and Last Name, DOB]
- Patient's DHS placement information [Resource/Foster Parent Name]
- Contact information for Patient's DHS placement [Phone number and Email address]

If the patient did not have a qualifying physical health assessment or wellness visit within the 30 days prior to the DHS notification date, EOCCO requests that your clinic outreaches to the DHS placement contact to schedule the patient for their DHS physical health assessment **before their 60-day appointment deadline**.

Qualifying Physical Health Assessment Codes for DHS

| Preventative Visits | 99381-99384, 99391-99394 |
| Annual Wellness Visits | G0438, G0439 |

***Note:** A 99201-99205 visit billed with a Mental health Diagnosis Value set ICD-10 code or ICD-10 code related to child abuse or neglect will count as both a physical and mental health assessment for a patient 3-17 years old.
